Charter Member Dr. Dahlia Hirsch - My Fondest CPWN Memories, The Early Years

When I started my practice in 1982, I immediately joined the Harford County Chamber of Commerce. I was completely surprised when 10 years later, in 1992 at a meeting with hundreds of men and only a handful of women, they announced an award that I had never heard of, the Athena Award, and myself as its recipient. I was most surprised that the recognition for my work in medicine and the community was coming from a group of businessmen. In spite of the fact that I had built a successful Ophthalmology practice, started outpatient eye surgery at Harford Memorial Hospital, taught at University of Maryland Hospital, while juggling a family life with three kids ages, 12, 11, and 6, a marriage, and launched the Sight for Life program to provide free eye surgery for the needy in our community, I still felt as if I was working in a man's world. I had just been invited to be the keynote speaker at a symposium of the U.S. Army to increase awareness for bosses of what it is like for women employees. That talk was entitled "Women Working in a Man's World". There were "almost no bosses" in the government. As many of you may have experienced as business women, to be assertive was considered aggressive, and to be successful was seen as a threat. So receiving this award, from the Chamber of Commerce, was both a surprise and an enormous honor.

The need for collegial relationships, the effectiveness of a support network, and validating communications led a handful of female Ophthalmologists in the mid-1970's to meet for 6:30 am meetings, noon-time luncheons, speakers, and networking at the Annual Meeting of the American Academy of Ophthalmology (AAO). In 1991 we started the International Women in Ophthalmology Organization, with female ophthalmologists who included Danielle Aron-Rosa from Paris, the inventor of the pulsed YAG laser, and Dr. Marguerite McDonald, who performed the first excimer laser eye surgery. I was honored to be a part of that small group and its contributions to my profession. The early women in ophthalmology were few in their respective departments and worked on such challenging issues as gender equity in pay, academic promotion and opportunities, and the need for recognition of academic achievement as well as the issue of balancing family and profession. I was just as honored when I got a call suggesting that I help organize CPWN- I saw it as an opportunity to really share what I had learned about business and to gain acceptance for women in business just as the WIO had done. I was the 1st female Ophthalmologist in Harford County, and one of very few surgeons at the hospital. I remember everyone trying to tell me I should wear blue suits ("Power Suits") whenever I gave a public speech, and to always wear a lab coat in the office to look "masculine and believable". It was my mom, who was one of the 1st women to be allowed into the AIA (Architecture Association), and a wonderful architect, builder and businesswoman who told me to dress with fashion, and I would set a new standard for women in medicine. That was wonderful advice. Being a part of CPWN we often laughed at how we were told how to fit into the mold, rather than create a new mold. We allowed each other to have sensitivities, and learn how to bring them into our businesses. We supported each other in following our heart, doing what we enjoyed, excelling in our fields, and learning how to do public relations to enhance our businesses.

I believe the CPWN has really kept to its mission well, and that the camaraderie, shared experiences, advice, and networking that is accomplished makes it a nurturing place for new business women, and a place for friends with shared experiences to meet. During my years as a practicing Ophthalmologist, then owner of a Holistic Healing Center and founder of Help, Consulting for Practice Management and patient advocacy, as well as my favorite mission as Facilitator of "A Course in Miracles" reading group at Upper Chesapeake, I always looked forward to the opportunity to be with so many accomplished and kind women, and I appreciate the officers for their dedication and hard work to help sustain the mission.

An Evening with the Former White House Pastry Chef

Ever dream about being wined and dined at a formal state dinner at the White House? Daniele Fleischer and Theresa Wiseman lived that very experience, well, sort of.

Chef Roland Mesnier, who served as White House pastry chef for 25 years, was the special guest at a gathering at The Center Club in Baltimore on September 29. A gourmet dinner was served, finishing with a dessert Chef Mesnier created for a White House event in years' past.

At the start of the evening, Chef Mesnier, in his white chef's hat and jacket, spoke with guests while they sampled hors d'oeuvres (smoked salmon profiterole, blini with caviar and crème fraiche, crab balls) and a selection of wines.

From there Chef Mesnier and guests moved into the Harborview Room for a spectacular view of the Inner Harbor and a sumptuous meal of lobster veloute with asparagus and chive oil; gathered greens with warm chevre strudel, assorted berries and black raspberry vinaigrette; and pan roasted loin of veal on butternut squash risotto and black truffle. The grand finale was pears in red wine sauce with rum raisin ice cream, a recipe from Chef Mesnier's cookbook, *Dessert University*.

Daniele had the opportunity to speak with chef in their native language—French. Like Daniele, Chef Mesnier was born in France, but that's where the comparison ends.

Chef Mesnier has worked at the Savoy in London, the Princess in Bermuda, and at The Homestead in Hot Springs, Va. He was hired by First Lady Rosalynn Carter in 1979 and prepared delicious desserts for state and less formal occasions at the White House for 25 years.

One of his most interesting accomplishments at the White House was serving a different dessert on each state occasion. Never during his 25-year tenure on Pennsylvania Avenue did he serve the same sweet ending at state events.

After the meal in Baltimore, Chef Mesnier reminisced about each presidential household for which he served. (If you want details, see Daniele or Theresa.) At the end of the evening, chef autographed a copy of his cookbook for each person in attendance. It was a magical evening in the company of friends.

Caribbean Shrimp with Fruit Salsa by Grace De Bruyne

Caribbean Shrimp with Fruit Salsa - Serves 10

Marinade

1 teaspoon allspice, ground
1 teaspoon cinnamon
1 teaspoon black pepper, ground
1/4 teaspoon nutmeg
1/2 small red onion
4 each scallion, chopped
2 cloves garlic, peeled
1/2 jalapeno pepper, seeds removed
1 1/2 teaspoon kosher salt
2 tablespoons soy sauce
1/4 cup vegetable oil

10-12 wood or bamboo skewers
1 pound shrimp, large, peeled and deveined

Fruit Salsa

3 cups, of any ripe fruit (pineapple, melon, mango, papaya, pears, apples), peeled and cut into 1/4" cubes
1/2 jalapeno pepper, seeded and finely chopped
1/2 small red onion, finely chopped
4 tablespoons of cilantro, chopped
zest of one lime
juice of two limes
1 teaspoon sugar

In a food processor or blender, puree together all the marinade ingredients, to form a thick paste. Coat the shrimp well with the marinade, up to 12 hours.

Meanwhile make the fruit salsa: Toss all ingredients together gently in a non-reactive bowl, cover and refrigerate. Serve within 12 hours.

Soak 10-12 skewers in water for 20 minutes. Place 3 shrimp on each skewer and cook on a very hot grill or grill pan for 1 1/2 minutes on each side.

Serve warm or at room temperature with Fruit Salsa.

Notes:

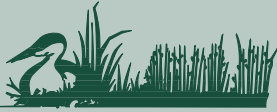
Substitute 1 pound chicken breast, sliced into strips. Cook 3 minutes on each side.

Light Version: Reduce the vegetable oil to 2 tablespoons.
