In addition, the grant also covers registration fees for the SAT.

Ready2Learn carries a large variety of school and office supplies available at no charge to teachers. The inventory is regularly updated and provides a safety net for those students who are unable to afford school supplies, backpacks, clothing or just about required to succeed in school.
